Please make sure you are in compliance with all of Barbourmeade's ordinances. You can view Barbourmeade's ordinances at www.barbourmeade.org or you may request a copy of our ordinances from our City Clerk. Our ordinances are in effect to ensure that Barbourmeade is a safe and beautiful City. The Barbourmeade City Commission makes every effort to ensure that ordinances are consistently enforced.

Your Barbourmeade City tax dollars have been invested in beautiful new signs and poles throughout our City. Please DO NOT affix any kind of sign to any of our signs or posts. Tape ruins the paint and finish and the damage is expensive to repair. Our City has an Ordinance against affixing anything to our sign and light poles. Individuals who affix signs to our sign and light poles will be fined.

With real estate and election season upon us, please remember that **no signage of any kind is allowed in areas the City maintains.** The only exception to this if for real estate signs which may be placed on City property from 5 p.m. on Fridays until midnight on Sundays. There is no signage allowed in Residents' yards except for real estate signs, yard sale signs, election signs, and business signs for work being done on your property (a contractor's sign may be placed in your yard for no more than 30 days.

Dog Owners

The Commission receives many complaints from residents about barking dogs. Please be considerate of your neighbors and if your dog is barking excessively, bring them indoors; it will give them – and your annoyed neighbor a chance to cool off.

Also, remember that there is a leash law in Jefferson County. Your dog(s) must either be in a fenced yard or restrained by a leash at all times.

Always pick-up after your pet while walking them throughout the City.

- The Commission is pleased to announce a new contract with Rumpke for City sanitation services, effective July 1, 2008.
- In addition to being at a lower rate than the City's previous contract, the new contract will have two additional benefits: (1) year round yard waste pick-up and (2) <u>AT RESIDENTS EXPENSE</u>, a green 95-gallon YARD WASTE can with

wheels can be leased for \$2.50 monthly. If you currently use several yard waste cans you may appreciate cutting down to one. You MUST call Rumpke at 568-3800 if you would like to have this service added. They prefer to bill yearly but will allow quarterly. ALL RESIDENTS WILL RECEIVE YEAR ROUND YARD WASTE REGARDLESS OF WHETHER THEY LEASE A CONTAINER OR NOT.

- Remember to put your trash cans out on Tuesday September 2 following the Labor Day Holiday on Monday September 1.
- As always be sure your yard waste cans or bags are clearly marked YARD WASTE, this includes large black bags. If Rumpke can't clearly tell that the bags are yard waste, they might choose to leave them in your yard. If you prefer stickers to mark your trash cans, please contact Commissioner Lisa Crockett or Rumpke to obtain stickers.
- If you find that you have a lot of recycling material, for a small cost Rumpke will provide you with additional recycling bins.
- PLEASE CONTINUE TO BRING YOUR GARBAGE CANS IN ON MONDAY EVENING.
