

CITY OF BARBOURMEADE
ORDINANCE NO. 6
SERIES 2018**

AN ORDINANCE establishing parking restrictions on certain types of vehicles including but not limited to; heavy equipment and/or vehicle, boats, trailers, recreational vehicles and tractor trucks, within the City of Barbourmeade. *With the passage of this Ordinance, Ordinance No. 13, Series 2007 relating to parking certain vehicles in the City, passed on February 19, 2007 is hereby repealed and replaced. ***

WHEREAS, the City, by and through its elected Officers, are desirous of passing this Ordinance for the general interest and well being of its residents.

NOW THEREFORE, be it ordained by the Commission of the City of Barbourmeade, Kentucky;

Definition:

“Enclosed Structure”- A structure with a solid roof and exterior walls. The exterior walls, excluding windows, must provide a visual screen of the items contained within the enclosed structure. The walls must be of a solid material and permanently connected to the overhead structure. Wood, concrete, aluminum, glass or other materials approved by the commission are permissible. Screening, fencing materials, shade cloth, plastic sheeting or canvas are not permissible.

- (1) It shall be unlawful for any person to park, store or otherwise maintain a boat, tractor truck, truck trailer, trailer, house trailer, disabled vehicle, recreational vehicle, motor home or any type of heavy equipment and /or vehicle including but not limited to; backhoe loaders, excavators, snow removal vehicles and/or tractors on any property within the City, *unless* it is enclosed within an enclosed structure as defined above, and in the case of a recreational vehicle, is not occupied as a dwelling or sleeping place. An *exception to enclosure* exists for construction vehicles and equipment being utilized for specific construction project(s) on public or private property within the City of Barbourmeade.
- (2) Notwithstanding the provision of Section (1) above, a City resident may on a temporary and very limited basis park his boat, tractor truck, truck trailer, house trailer or recreational vehicle and/or motor home in the driveway of his dwelling for a period not to exceed seventy-two (72) hours for the purpose of loading, unloading, cleaning, repairing and/or servicing. It is the Commission’s purpose to provide this exception for very infrequent situations. For example, in the spring, if a resident wants to bring his/her boat to the residence and prepare it

for the summertime, they have 72 hours to do so. It is not meant to allow any of the prohibited vehicles and/or attachments to remain at a residence for a period longer than 72 hours or for a limited purpose other than a situation as illustrated by the example above. The same intent extends to paragraph (3) below.

(3) A recreational vehicle owned by a person who is not a resident of this City and is a guest of a resident of this City, may be parked for a period not to exceed seventy-two (72) hours in the driveway of the residence in which the recreational vehicle owner is a guest.

(4) For purposes of this ordinance, the time period of seventy-two (72) hours need not be continuous. The intent of the Commission for this provision is to prevent someone from moving their prohibited vehicle and/or attachment every 72 hours to thwart the exception provided for in paragraphs (2) and (3) above.

(5) **PENALTY** – Violation of this Ordinance shall constitute a violation and carry a fine of \$100.00 per offense. Each day a violation of this ordinance continues shall constitute a separate and distinct offense potentially resulting in cumulative fine(s).


FURTHER, this Ordinance shall take effect upon approval, passage and publication as required by law.


