


Beautification News

The new sidewalk on Barbour Lane continues to draw people from other areas of Barbourmeade as well as areas across I-71. Trash and dog waste are much more visible on the new concrete and blow into yards as well as the street. PLEASE put trash in your pocket and clean up after your pet.

A revision to Ordinance #13 is in progress to more closely parallel Metro Ordinances regarding the parking and storage of commercial vehicles, heavy trucks, and commercial trailers on private property.

If you notice any of the lights out at the entrance signs please e-mail beautification@barbourmeade.org or call 425-0750. There is an ongoing problem with vandalism at the Pinehurst entry light which we plan to have rectified soon.

REMINDERS

Rumpke's policies on setting out your yard waste:

- Place yard waste loosely in 30-35 gallon cans or PAPER or PLASTIC clearly labeled "yard waste" (stickers are available if you contact Lisa Crockett or Rumpke)
- Brush and branches should be tied in 4ft. lengths weighing no more that 75lbs. For your convenience, a 95 gallon waste wheeler for YARD WASTE ONLY can be leased by individual homeowners for \$2.50/ month. This cuts down on bag usage and allows Rumpke to move through our City faster. Please call Rumpke at 568-3800 to lease a waste wheeler.

Rumpke is not obligated by contract to pick up any more than 10 bags/bundles or cans per household each week. However, this policy is not usually enforced except in unusual situations like the ice storm.

Call Rumpke ahead of time to arrange pick-up for large items like furniture or appliances.

If you are not recycling and would like to start, Rumpke will provide you with a red recycling container.

Please continue to keep our City looking beautiful by NOT putting your trash cans or yard waste out before late afternoon on Sunday and bringing cans in by Monday evening. THANK YOU!!!!

Safety News

DO NOT open your door to strangers. Also, for your safety, close and lock all your doors and windows, provide good outside lighting and keep your valuables out of sight. If you experience a home or car break-in or vandalism, PLEASE file a report with the Meadow Vale Police Department. Also, please use the Meadow Vale Hot Spot Traffic/Ordinance/Criminal Activity Form found on the City's website if you would like to report any problem situations in writing.

Also, PLEASE observe the following:

- Snow Parking: Do not park on the street during snowy weather as the snowplow needs ample room to clear the street
- Do not place yard waste or garbage cans on the street as they impede traffic
- Do not speed or run stop signs, citations (not warnings)
 will be written 14 citations written in recent months
- Do not impede traffic when parking on the street and park with the passenger side on curb. Guests should be on one side of the street only
- Do not park within 30 feet of a STOP or Yield sign
- Please call LG&E for the following: street light outage –
 589-1444; electric trouble 589-3500; gas trouble 589-5511
- · Have a visible house number and good outside lighting
- Our Police will check your house when you go out of town upon request

Insurance Taxes

Your insurance company should list on the policy declarations page the premium liability charge, state surcharge and <u>premium tax</u>. The premium tax should designate Barbourmeade. If it does not, PLEASE call your insurance company AND advise Dan Streit (see above). Premium tax is charged on liability insurance such as auto, boat, homeowners or renters, personal umbrella and first years life insurance premium. PLEASE check all policies. These tax dollars should come to Barbourmeade to benefit you.
